## Section 4. First aid measures

### **Description of necessary first aid measures**

Eye contact

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. ### **Precautions for safe handling**

### Appropriate engineering controls
