## Description of necessary first aid measures

### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

### Methods and materials for containment and cleaning up

Small spill

## Precautions for safe handling

Protective measures

Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. # Appropriate engineering controls

: Use only with adequate ventilation.
