Description of necessary first aid measures

Eve contact

Methods and materials for containment and cleaning up

Small spill

Large spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Avoid exposure - obtain special instructions before use. Avoid exposure during pregnancy. Do not handle until all safety precautions have been read and understood. Do not enter storage areas and confined spaces unless adequately ventilated. Appropriate engineering controls

n-butyl acetate


