Description of necessary first aid measures

Precautions for safe handling

Protective measures	: Put on appropriate personal protective equipment (see Section 8). Section 8. Exposure controls/personal protection

Appropriate engineering controls	: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
