Description of necessary first aid measures

Eve contact : Get medical at

Methods and materials for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not enter storage areas and confined spaces unless adequately ventilated. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Section 8. Exposure controls/personal protection

Appropriate engineering controls


