Description of necessary first aid measures

Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Section 8. Exposure controls/personal protection

Appropriate engineering controls

: Use only with adequate ventilation. 
