SECTION 4) FIRST-AID MEASURES

Inhalation

Eliminate all ignition sources if safe to do so. Remove source of exposure or move person to fresh air and keep comfortable for breathing. Call a POISON CENTER/doctor. SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Dry chemical, foam, carbon dioxide water spray or fog is recommended. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. Sand or earth may be used for small fires only.

Unsuitable Extinguishing Media

Specific Hazards in Case of Fire

Can form explosive air mixtures.

Emergency Procedure

General

Eye Protection
