#### **Description of necessary first aid measures**

Eye contact : Immediately

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

#### Methods and materials for containment and cleaning up

Small spill

# Section 7. Handling and storage

## Precautions for safe handling

Protective measures

Avoid exposure - obtain special instructions before use. Avoid exposure during pregnancy. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. # Appropriate engineering controls
