#### **Description of necessary first aid measures**

Eve contact

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. #### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

#### Methods and materials for containment and cleaning up

Small spill

Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

### Precautions for safe handling

Protective measures


