Inhalation

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ## Methods and materials for containment and cleaning up

Small spill

# Section 7. Handling and storage

#### Precautions for safe handling

#### **Protective measures**

# Appropriate engineering controls

**ETHYLBENZENE**
