## Section 4. First aid measures

#### **Description of necessary first aid measures**

Eye contact

Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Chemical burns must be treated promptly by a physician.

Inhalation

Ingestion

### Section 6. Accidental release measures

#### Methods and materials for containment and cleaning up

Small spill

## Section 7. Handling and storage

#### **Precautions for safe handling**

**Protective measures**

Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. # Appropriate engineering controls


